7. Election of Office Bearers

Ken Hurling thanked the office bearers for their work over the past year.

President - Ken Hurling (Qld); Vice president - John d’Helin (VIC); Secretary - Kevin Phillips (NSW); Treasurer/Public Officer - Geoff Lucas (NSW). Elected unopposed.

8. Sub-Committee Representatives

Youth Director Don Elks has resigned, and we are looking for a volunteer to take on this role.

9. Resolutions to Change ILCA Australia Constitution

The three resolutions required by the regulator previously posted and attached were passed unanimously.

10. ILCA Worlds Ranking & Qualification

A question was raised about World Championship ranking. The response offered is.

Ranking for entry for ILCA Worlds Championships is posted on the ilca.au web site.

In summary - The ranking is based on results of the most recent relevant National Championship - Open & Youth or Masters. The qualifying events are identified on the ilcas.au web site.

In more detail - Ranking is based on World Sailing 100 point system – 100 points for 1st and 1 point for last place – these are scaled to the number of sailors in each age category. When there are sailors applying who qualified sailing in a different class from that of the World Championship event – such as sailors qualifying in ILCA 6 at Nationals applying for Under 21 Worlds (sailed in ILCA 7) the points earned in another fleet (ILCA 6 in this case) qualification are discounted by 25%.

11. General Business

There was discussion on the following.

3rd Party Liability Insurance

Need for 3rd party liability insurance for sailing internationally and also for Solidarity Program Australian and overseas sailors. Network Steadfast now have policy for overseas events but the insurance offered by ILCA Charter provider Ziegelmeyer for their supplied boats is much less expensive. For Australian Solidarity sailors the vast majority of Australian boat and 3rd party insurance policies cover sailors when in a charter boat provided their own boat is not used at the same time. For other Solidarity cases the only option is to take out the Network Steadfast insurance.

Support and Coaching for Youth World Championships

Australian Sailing have moved to part supporting youth sailors for the ILCA6 Youth Worlds and arranging pre regatta preparation and event coaching.

Following the resignation of Don Elks support for ILCA4 Youth and U21 Worlds is arranged by parents and mostly by engaging Malta based SailCoach. We are still searching for a Youth Representative to co-ordinate this currently ad hoc activity.

Longevity of ILCA6 Sail

The long term issue of longevity of ILCA6 sails was raised. Ken Hurling reported that afterv extensive ILCA development and testing 2026 should see the introduction of new design ILCA6 and ILCA4 sails using heavier sail cloth.

U21 ILCA World Championship Bid

ILCA Victoria is working on a bid for the 2027 ILCA U21 World Championships at Sandringham YC.

ILCA Australian Events

- Strong entries in Australian District & National events
- 2024 Oceania & Australian Open Youth & Masters Events saw 330 sailors competing
- Great to see numbers of international sailors competing at these events
- 2024 ILCA 7 and ILCA 6 & 7 Masters World Championships in Adelaide saw 360 sailors enjoy terrific competition in great if at times challenging conditions
- Almost half of the competitors in the two Adelaide Worlds were sailors from Australia
- Thanks to ILCA SA and Adelaide Sailing Club for the great organisation of these events
- With such strong attendance at World Masters numbers were down as expected for National Masters at RQYS but all enjoyed the event and the club hospitality



World Events Success

- Oceania achieved great 2024 Olympic results with Matt Wearn winning his second and Australia's fourth in a row in the class. Zoe Thomson was a creditable 20th
- Matt also won the ILCA 7 Worlds in Adelaide with Swifto Elliott finishing 10th
- The Australian ILCA 6 squad had great success in the big European events with Zoe Thomson 2nd in the Princessa Sofia and Mara Stransky 2nd at Kiel Week
- Evie Saunders was second in the ILCA 6 U21 Worlds in Portugal. Isaac Schotte was 10th in the ILCA 7. 235 competed with 13 Australians
- Healy Ryan won U17s at European ILCA 6 Youth Championships in Bangor, Northern Ireland there were 7 Australian among the 360 sailors competing
- Australia was the standout success in World Masters 2025 winning 5 of the 9 age divisions



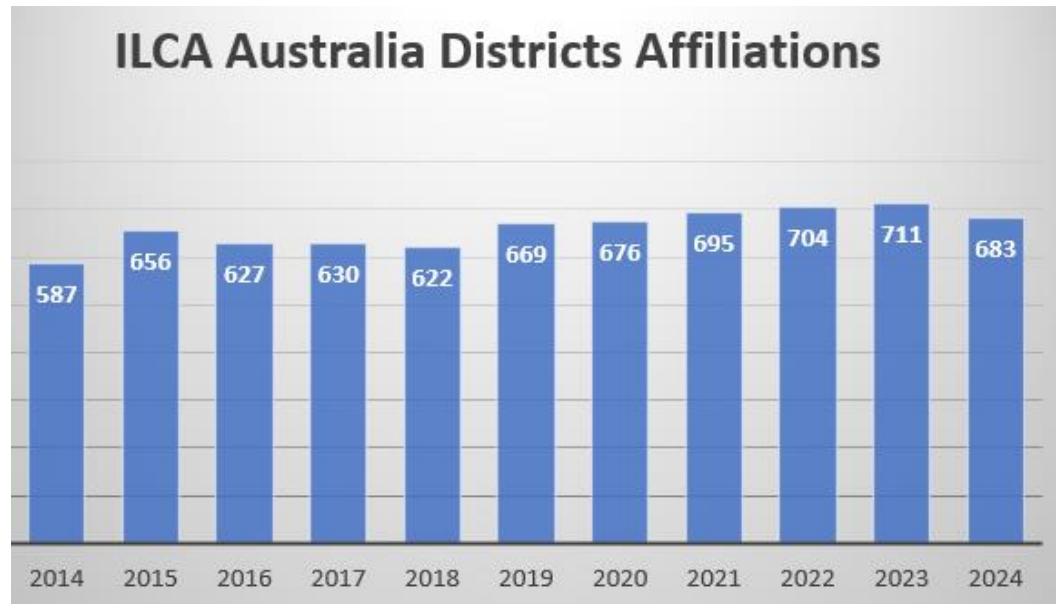
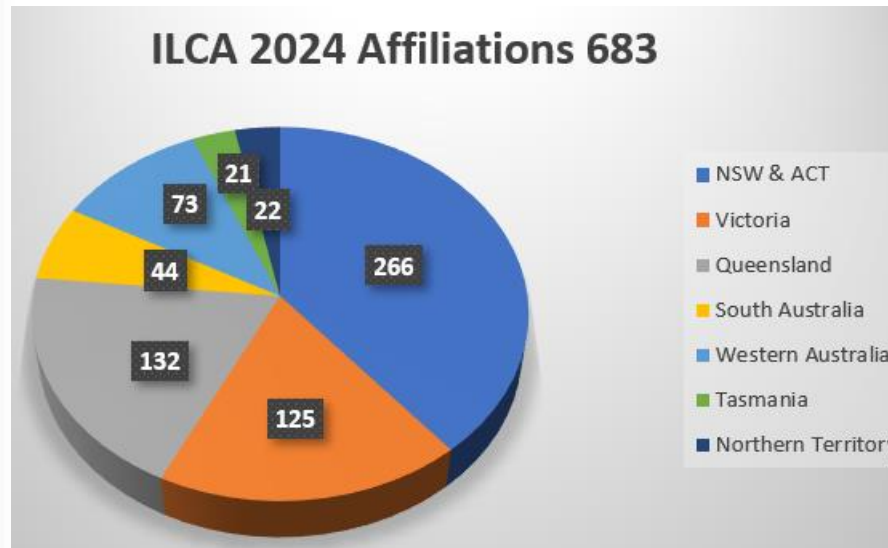
ILCA Australia Organisation

Treasurer's Report Year Ended 30 June 2024

I have pleasure in presenting the financial statements for the above financial year.

The Income & Expenditure Statement shows an excess of expenditure over income for the year of \$1,732.39.

The income from membership subscriptions of the various Australian districts was up marginally by \$491.00.

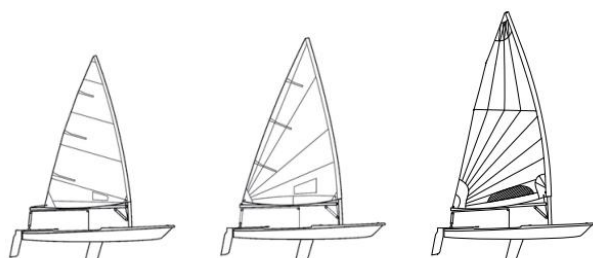
Expenses for the year were down by \$2,237.02. The decrease was mainly due to there being no cost this year to ILCA Australia for the Solidarity Coaching Program.

The 3rd Party Liability Insurance premium of \$1,789.59 covers all state and territory districts in Australia for that liability. The premium cost of this cover remained virtually unchanged from the previous year.

The Balance Sheet shows the net assets of the Association are \$20,849.75 which is represented by the funds held at Westpac. The Association does not have any liabilities as it is not operating any more as the trust account banker for junior Australian competitors in overseas regattas.

2024 Annual report

ILCA sailing has continued its success in the NT with consistent numbers on the water participating in club races, regattas and training events. The Class is very visible on the water with all rigs regularly sailing. The ILCA 4 has proved popular and is now recognised as the natural progression from Minnows and training fleets. This has played a big part in keeping the numbers up as some of the older teens leave to attend universities in the southern states. 2024 has also seen NT ILCA members competing in International and National competition with members sailing in ILCA Masters World Championship, ILCA Australian Championship and Queensland YouthSail Week. There are 11 ILCA NT members competing in the upcoming 2025 Oceania & Australian Open & Youth Championship.

In 2024 the ILCA remains the most active class at the Darwin Sailing Club and ILCA outnumber all other classes in club and championship racing. A fleet of 15 plus ILCAs regularly sailed through the 2024 season covering all rigs with results awarded on yardstick as well as scratch results. Due to the consistent numbers of ILCA on the water the Darwin Sailing Club recognises the ILCA as an individual fleet and provides separate start for the Class in its club racing.

In late 2026 the ILCA NT will again host the Oceania ILCA Masters Championship in Darwin. The Championship will be hosted by the Darwin Sailing Club and is seeking support and sponsorship from the NT Government, Northline Transport Logistics and local businesses as well as the Darwin Sailing Club and Waterfront Bistro. We will also be approaching our friends at Ronstan, SEA, PSA, and NB Sail Sports, to become a sponsor and support this regatta. The regatta will be held in August or October and will be planned around the best tides at the time. Racing will consist of afternoon starts to take advantage of the seasonal sea breeze. The last Championship attracted 37 entries with the after effects of the COVID travel restrictions taking their toll on the response. For those who did attend, the racing was close and the atmosphere friendly and I think all agreed that it was a regatta worth attending and vowed to return in 2026.

ILCA sailing is thriving in the NT and the visibility and success of the class is proof of this. The NT sailing season runs from April to October, the water is warm and flat with 8 to 12 knots of breeze and up to 25 knots late in the season making Darwin the ideal place to spend the cold winter months.

Unfortunately, we had to hand over the Batters Trophy to Queensland at the end of the Nationals but still finished ahead of our old rival WA.

The Vic Masters had some sensational results in the Adelaide Worlds. In the ILCA 7 GGM's, Steve Gunther finished first counting 9x bullets & 2 x seconds. In the ILCA 6 GM fleet Mark Tonner-Joyce finished 2nd, Damon Cook 9th & Nick Ede just out of the top 10 in 11th place. James Mitchell took the chocolates in the GGM with a sensational score card that include 6 bullets. Tony McPhail (can't wipe the smile off his face) finished 5th followed by our new Ilca Vic secretary Robert Jeffery's. Well done all.

ILCA Vic head coach Rhett Gowans retired from the position after 3 years of service. Rhett won the 2017 Radial Australian championship & was offered a VIS scholarship. Later he became a coach for the VLA & has helped many Victorian sailors improve their performance. As head coach his management skills were instrumental in proving the mid-week Green Point training sessions could work. Thanks Rhett, we wish you well for the future.

ILCA Vic board changes. Tony McPhail resigned from the board at the AGM after many years of service including in the role of secretary. Thanks, Tony, for your contribution. This year we have welcomed Christian Cantwell to the Ilca Vic board. Christian has previously served on the VIODA committee including some time as President.

The recent Vic champs at Blairgowrie YS saw a fleet of 100+ for the second year in a row. Unfortunately, due to bad weather the championship was

abandoned after one race. Our thanks to Andrew (Boomer) Crawshaw for organising this event.

One of our highlight events every year is the visit to Lake Eppalock (near Bendigo) on Melbourne Cup weekend. Two days for the Inland waters' regatta followed by 2-days of coaching. Our thanks to Andrew Prest for organising this event & Col Dods for the PRO role.

The Ilca4 numbers are growing as more clubs are realising that this is the best option to transition their junior sailors. We will continue to focus building club fleets via the Ilca pathway with a strong focus on transitioning our Ilca4 girls into Ilca6's as they are for the next step.

We settled down to a less hectic season after hosting the 2023 Oceania & Australian Open & Youth Championships at Georges River sailing Club and the Oceania & Australian Masters Championship at Bay Sailing Centre Port Stephens. This year the big events were focussed on Adelaide with the Open & Youth Championships followed by two Worlds the ILCA 7 Men's and the World Masters mostly sailed in strong winds at Adelaide Sailing Club at Glenelg.

Congratulations to RSYS/DBSC sailor Brooke Wilson who sailed a fantastic series to take out the ILCA 6 Open Championships in Adelaide.

International Sailing

WA sailors Matt Wearn and Zoe Thomson represented Australia in 2024 Olympics in Marseille. Matt won his second and Australia's fourth gold in succession in the event.

Local sailors were well represented in the six ILCA World and some EurILCA Championships in the past year. Notable local sailors were Healy Ryan who won the U17 in the European ILCA 6 Youth Championships in Northern Island and Evie Saunders who finished 2nd in the 80 boat U21 Worlds in Portugal.

28 Australian sailors competed in the ILCA 7 Worlds in Adelaide and 130 Masters sailors competed in the Masters Worlds later at the same venue. Matt Wearn finished on top in the ILCA 7s. Australian sailors won four of the Masters categories. Notable local Masters performances were from Brett Beyer winner ILCA 7 GM, Tim Alexander and Rob Lowndes 2nd and 3rd ILCA 6 Legends, Bruce Savage 3rd ILCA 6 GGM, Rick Longbottom 3rd ILCA 6 GGM.

Vai Ripley who sails at MHASC represented Samoa in the 2024 Olympics in Marseille.

NSW & ACT sailors Evie Saunders and Tom Farley were selected as part of the eight-sailor team to represent Australia in the Pacific Games to be held in Honiara, Solomon Islands from 19 November 2023. These games held every four years include Men's and Women's ILCA 6 and ILCA 7 and Sailboard competition among 24 sports.

ILCA NSW ACT District Sailing

For our NSW & ACT events we had 60 sailors competing in each of the Coast Championships at Gosford SC in 2023 and a new venue for us Mannering Park ASC on Lake Macquarie in 2024.

78 sailors enjoyed the sailing and two-day workout at the Open & Youth State Championships at Georges River Sailing Club over the weekend 16-17 November.

On both days there were good NE 13-20 knot breezes. On Sunday the forecast was for over 30 knots NE with a maximum runout tide in the afternoon, so it was wisely decided to make a 0900 start to the proceedings. Great to see the AS ILCA 6 Squad competing at this event.

Our Metropolitan Championships was held at Vaucluse YC. VYC is a fabulous small club however the waterway proved quite challenging for sailors and officials alike with 18 footers, ferries, tide and leisure boating traffic all having to be negotiated.

Thanks to the host clubs for putting on a great show for us. The on the water and in the club house teams make the events work. They do it just for the love of the sport and we thank them one and all.

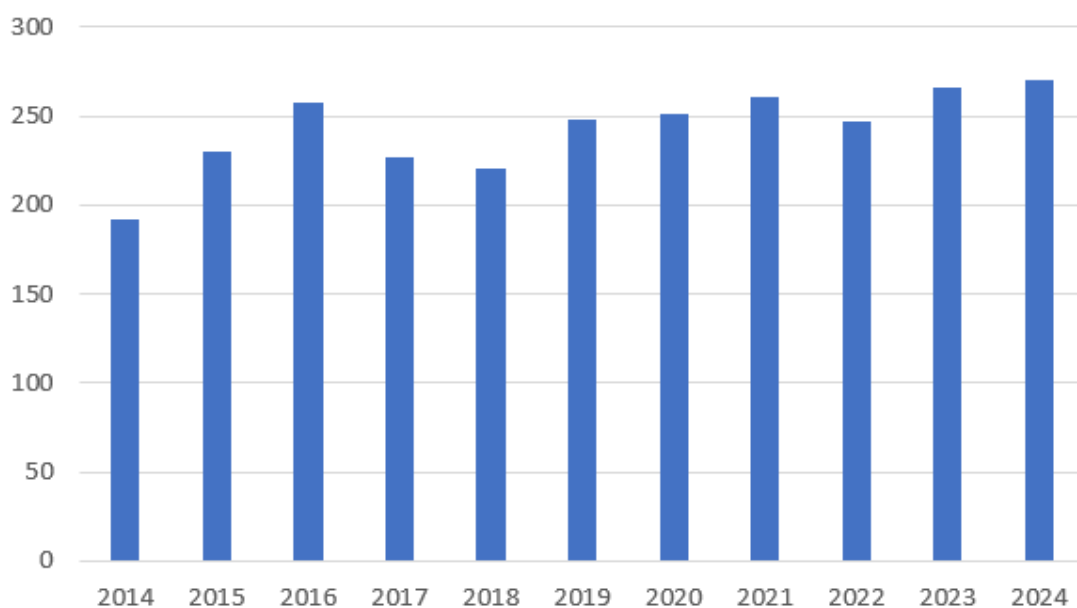
Everyone knows that the cost of everything is up as well the costs for clubs hosting our events and our own costs are way up. We have had to increase the entry fees to reflect these costs with our aim /to break even running events overall.

NSW/ACT Membership

Our District membership for the year increased slightly to 270 (from 266 in 2023 season). Our 10-year average membership is 248.

We pass more than half of our collected membership fees onto ILCA Australia and ILCA International through affiliations (\$23 per member to be exact) to help to support their activities. The greater the number of Australian Laser sailors we have as members the larger our allocation of places in limited entry World Championship events.

NSW & ACT Memberships



From this season we are including membership with race entry so anyone who sails in any of our events in a season is a financial member and can sail in other interclub, national and world championships. This arrangement makes our job of managing membership much easier. Sailors who wish to sail in other events (nationals, worlds etc.) but who haven't entered any of ours can still simply pay \$40 (\$20 if under 21) online.

Changed Name & New Constitution

The fabulous work of our Treasurer and Public Officer Geoff Lucas has managed to navigate us through the constitution, banking and administration changes required for our name and banking changes. Thanks Geoff.

District Administration

Hopefully we are keeping sailors informed on sailing, events, results and Laser sailing happenings through laser.asn.au. We send regular messages via email. We currently have over 600 people on our email distribution list.

A special thank you to our own small team of helpers R.O. Andrew McLachlan, our treasurer Geoff Lucas, race secretary Sue Phillips, regatta helpers David & Elaine Edmiston and VC Ben Byford. 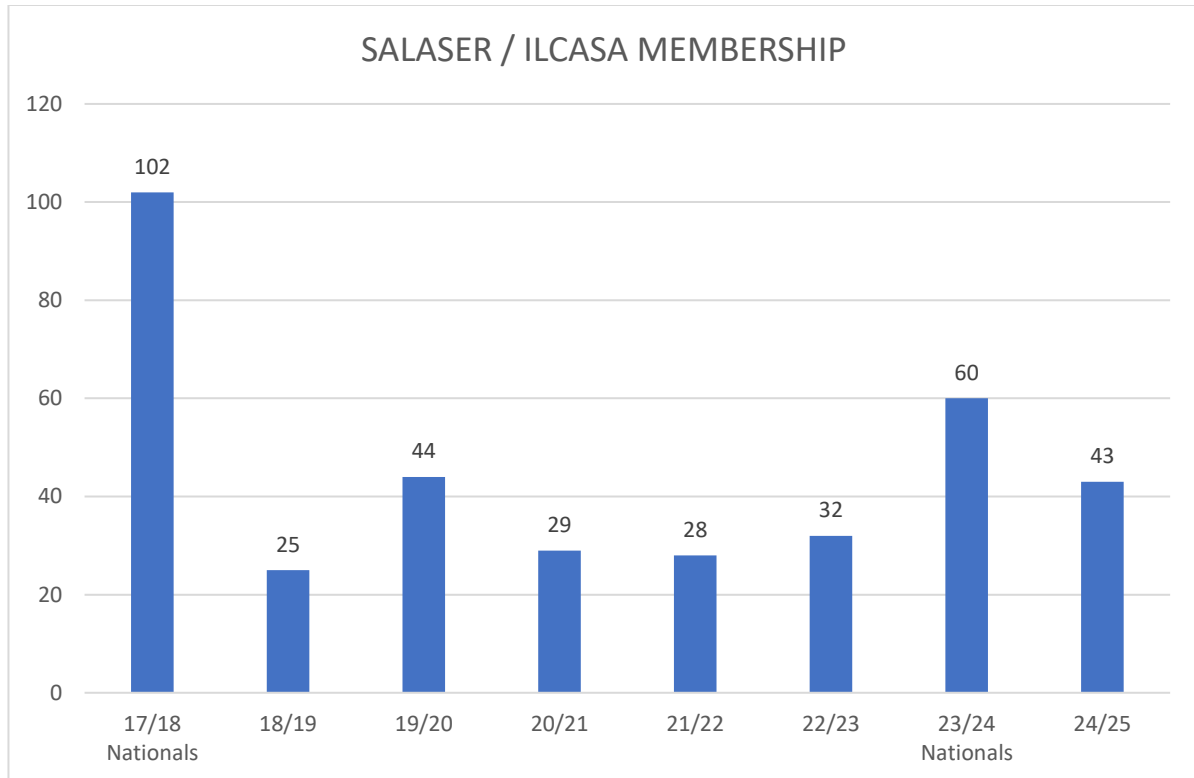
Thanks to the many people who helped out with administration and on the water for our events. Without people just stepping up as required we could never have managed the tasks involved in staging these events.

MEMBERSHIP

In the 2024/25 Season – ILCASA have 43 registered members. Although a dip down after hosting the Nationals (as is historically anticipated) we hope to continue the upward trending membership base in recent years.



In South Australia, the two predominant youth classes after optimist is either the ILCA or the 420, with some in the Cadet class.

At BSYC, parents (Dads generally) have taken the opportunity to take up the ILCA and sail alongside their kids in the class. This has been a fun engaging experience for the families.

2025 Nationals Attendance: -

SA have 5 sailors attending this years Queensland Nationals, this is by comparison to 8 SA sailors travelling 2 years ago to NSW Georges River. Transport costs and logistics to Queensland have played a factor in the number able to go.

ILCA 2024 NATIONALS AND MENS & MASTERS WORLDS Jan 2024



Last years ILCA Oceania and Australian Championships (2024) was the lead out event to both the ILCA7 Men's Worlds and Masters Worlds, all held at Adelaide Sailing Club (ASC) over a near on 8 week period.

Adelaide Sailing Club(ASC) were a standout event leader and Organising Authority for these 3 events. The ILCASA committee worked along side the Host club, in both the planning and delivery of these 3 major events. However, it must be acknowledge the ASC's team, led by Peter Royle, Malcom Hughes and Donna Evans- were outstanding in their vision, preparation and tireless efforts to bring these 3 events together successfully and deliver them seamlessly one after the other over the January / February timeframe.

- 258 Sailors participated in the Australian Nationals
- 152 ILCA7 Men sailors participated in the Men's Worlds
- 222 Masters sailors participated in the Masters Worlds

... that's 632 sails and rigs that went through a full measure!

We thank all the team at ASC greatly for their efforts and those of the ILCASA committee that supported and provided input through the planning stages and then through implementation and finally to all our ILCASA members and friends then turned up for measurement- amongst many other volunteer tasks over the 3 events.

From the then ASC Commodore (Peter Royle) and Vice Commodore (Malcom Hughes) :-

We are incredibly proud to say that by all accounts, and backed up with considerable feedback from many local, interstate and international visitors and competitors, many who have sailed at multiple World Championships and Olympics, that the 2024 ILCA World Championship Regattas set a new benchmark in best practice regatta planning, delivery and management. We had thought through and planned for virtually every scenario and contingency which translated on a daily basis to an extremely well run series of regattas.

None of this would have happened without the following:

- *Nearly three years of planning*
- *A very capable and experienced host club*
- *An incredible 90+ volunteers each and every day over a total of 24 regatta/race days*
- *The strong positive working relationships with our Sponsors, Partners, Supporters and contracted providers*

COACHING/CLASS DEVELOPMENT

SALASER continue to work with a small handful of coaches

- Ben Hinks- Club and Performance development coach
- Stuart Templeton- ILCA 4 fundamentals coach
- Adam Spees- (Regional South Coast) Fundamentals coach

Currently only two clubs (BSYC & GSC) run active training sessions for ILCA sailors. This generally is restricted to one day/week.

ILCASA continue to support and run a September Coaching Clinic- which is well attended by the youth ILCA members.

The local clubs (predominantly BSYC and GSC) remain the main provider of structured weekly and ad hoc coaching opportunities. Currently ILCASA are looking to work with the Victor Harbor Sailing Club to assist them in introducing / cementing the ILCA as a single handed boat choice/option. Support of our regional sailors is somewhat challenging (Port Lincoln ILCA sailors are some 800km from the metropolitan clubs) – but we continue to offer low to no cost association equipment usage when they come over for events to assist with creating opportunities.

Performance development opportunities in the ILCA in SA are supported by a number of the SA ILCA sailors engagement within the emerging and pre emerging Australian Sailing Coach programme. Queensland ILCA Report 2023 -2024

December 2024

The past twelve months has been a positive year with stable membership and healthy regatta numbers. In April we held the Australian Masters Titles and of course we are now holding the Open and Youth National Titles which at the time of writing looks like having a very healthy entry list of around 225.

QLA Regattas: This year we held our State Titles at Lake Cootharaba, situated north of Noosa and for the third year in a row we attracted over 100 entrants.

We hope to achieve similar numbers at the next States in April and which will be held at Kepple Bay Sailing Club at Yeppoon, some eight hours drive north of Brisbane. We believe holding our State Titles in regional areas has contributed to the growth of our membership over the last eight years

The South Pacific Laser Masters was re-scheduled back to it's usual July timing but due to the regatta load of Worlds in Adelaide we had a smaller than usual entry for SPLM. We are hopeful that this year we will see entries rise again.

Our Metropolitan Titles were held at RQYS in November and proved successful with 45 entries even though there were 11 Queensland sailors competing at Sail Melbourne at the same time.

Our River titles continue to struggle to attract large numbers of entrants although they are always an enjoyable day. This year they were hosted by Southport Yacht Club with 19 entrants. Notwithstanding the low numbers overall, the representation from SYC was pleasing.

Membership: Our membership numbers continue to be historically strong. Membership currently sits at 115 members which is lower than our number from the last few years. We typically see numbers rise in the new year as Masters sailors re join to compete in the Aus Masters and our States. Membership numbers quoted in our annual reports are usually based on the numbers at the time of our AGM which coincides with our State Titles in March/April.



Organisational Issues:


QILCA: We completed the transition from QLA to QILCA this year

Special Resolutions to Amend ILCA Australia Constitution

1. Change of Financial Year Due to AGM Timing
2. Distribution of Property in the Event of Winding Up

Annual General Meeting ILCA Australia 5 January 2025

Background

Resolution 1

The regulator for ILCA Australia, Fair Trading NSW, requires the Annual General Meeting (AGM) to be held within six months of the end of the financial year.

The AGM of ILCA Australia Inc. is held in January of the succeeding year when delegates are present at the Australian Championships which are now held 1-8 January. This results in difficulty in that we need to apply to Fair Trading each year, and pay the appropriate fee, for permission to hold our AGM after the six months statutory period allowed to hold an AGM.

Therefore, it is proposed to amend the stated financial year in the Constitution from 30 June to 31 July which then will bring the date of our AGM to within the allowed statutory six month period.

Resolution 2

The Australian Tax Office requires that a provision must be included in a not for profit organisation's Constitution preventing the organisation's assets or income from being distributed to its members except for provision of bona fide services or refunding of expenses incurred.

Resolution 3

The Australian Tax Office now requires not for profit organisations to have in their Constitutions, a clause covering how their surplus property is to be distributed in the event of their being wound up.

Special Resolution Motion

Moved Geoff Lucas seconded Kevin Phillips that the following two changes be made to the ILCA Australia Inc. Constitution.

Resolution 1 That clause 46 of the Constitution of ILCA Australia Inc. be deleted and replaced with the following clause 46:-

46 Financial Year

The financial year of the association is:

- (a) the period of time commencing on the date of incorporation of the association and ending on the following 30 June and
- (b) the 13 month period of time from 1 July 2024 to 31 July 2025 and each 12 month period thereafter commencing on 1 August and ending on 31 July.

Resolution 2 That clause 47 of the Constitution of ILCA Australia Inc. be deleted and replaced with the following Clause 47:-

47 Not-for-profit

The assets and income of the association shall be applied solely in furtherance of its above-mentioned objects and no portion shall be distributed directly or indirectly to the members of the organisation except as bona fide compensation for services rendered or expenses incurred on behalf of the organisation.

Resolution 3 That the Constitution of ILCA Australia Inc. be amended by inserting the following clause 48:-

48 Distribution of property on winding up of association

- (a) Subject to the Act and the Regulations, in a winding up of the association, any surplus property of the association is to be transferred to another organisation with similar objects and which is not carried on for the profit or gain of its individual members.
- (b) In this clause, a reference to the surplus property of an association is a reference to that property of the association remaining after satisfaction of the debts and liabilities of the association and the costs, charges and expenses of the winding up of the association.
